## Engaging Councils Key Goal for FY23

**IECA sought opportunities for councils to provide input, voice their needs, learn from one another, and tell their stories.**

As a result of working on our IECA Action Plan for 2022-2025, the activities of the association focused on providing opportunities for council members to engage more fully in their role with ISU Extension and Outreach.

In the fall, IECA launched a member benefits survey to learn more about the current benefits that are valued by councils, new benefits they may be interested in, and their concerns. Survey results will inform IECA's work as we continue to work to serve the needs of councils.

IECA ensured that Extension council members played a key role in crafting an updated memorandum of understanding (MOU) between

Iowa State University and extension districts. They were also represented on the Vice President for Extension and Outreach search committee.

The association also helped facilitate council members engaging with one another through both virtual and in-person trainings offered this year. We continue to look for opportunities to help councils share ideas with one another and with Extension and Outreach administration. This cross-pollination of ideas helps improve our systems to better meet the needs of Iowans.

The legislative breakfast in March was an opportunity for council members to share Extension and Outreach's impacts with legislators, helping them to understand the public value of our work.

# Memorandum of Understanding Renewed

Extension councils were well-represented on the Memorandum of Understanding Renewal Committee.



Over the course of six months, the MOU Renewal Committee reviewed the previous agreement and recommended changes for the new MOU which is effective July 1, 2023, through June 30, 2026. The revised MOU clarifies the roles of councils, the regional director, and the Model 3 county director. Items of note in the new MOU are an updated

Shared Services Support Fee structure and supervision responsibilities. IECA board members Jamie Thompson (Mills Co.) and Tom Monroe (Scott Co.) served on the committee as well as council members Mary Beth DeWall, Lori Donahoe, Dennis Goering, and Paige Grandgeorge.

## IECA Member Benefits Survey Yields Insight

In the fall of 2022, IECA asked each county extension council to take a few minutes out of their meeting to answer questions related to which IECA membership benefits they value and what ideas they might have for additional benefits that the association could provide. Additionally, IECA asked them to reflect upon their significant impacts from the last year, the challenges they face, and why they were motivated to serve on the extension council.

Overall, we found that councils appreciate the benefits that IECA offers. They had some ideas for group purchasing and a few additional ideas for potential new benefits that IECA might be able to offer. The board of directors will be

looking at both of these questions to see where we can continue our service to council members.

Council members shared their successes from the last year. A sense of pride is evident in their accomplishments. Similarly, reading their list of challenges can also elicit strong emotions. Some of their challenges are beyond the scope of what IECA is able to impact, but others inspire the to work with Extension and Outreach administration to find solutions.

## Councils Continue to Benefit from Legal Counsel

Extension Districts continue to encounter issues that are exclusive to the complex roles that extension councils balance.

During this fiscal year alone, IECA provided the member benefit of complimentary legal services to 33 counties navigating tricky situations ranging from personnel issues to real estate to partnership agreements. Whitfield and Eddy suggested changes and approved the final draft Memorandum of Understanding between extension districts and Iowa State University.

Whitfield and Eddy attorney Kay Oskvig provided a free webinar Best Practices for Personnel Committees and Personnel Records and also presented a breakout



session at the March 2023 Extension Council Conference overviewing the most common issues facing extension districts.

The hourly rate for legal services increased from \$205 to \$250 per hour this year.

# IECA Shares Best Practices

IECA strives to keep councils informed of their legal obligations as well as protect their best interests in policy development. Best practices were shared in the following trainings. Most are recorded and can be found on the IECA website under the *Council Training* tab.

Regenea Hurte, ISU Extension and Outreach administration; shared how councils and extension district staff can reach underserved audiences and reach all Iowans.

## New Council Orientation

Held following the 2022 council elections, the orientation provided a targeted overview of extension council member responsibilities.

## Extension Council Conference

Over 130 council members and staff attended this year's conference, which was held virtually on two evenings. Each session included a keynote address, an optional networking opportunity, and breakout sessions. The fifteen breakout sessions are recorded and posted on the IECA website.

## Legislative Breakfast Highlights Accomplishments and Funding

### Extension council members and staff met with legislators at the Capitol in March

The 2023 Iowa legislative session had a few issues that affected extension districts, most notably changes in property tax calculations. IECA monitored the proposed legislation and shared the impacts with county extension councils.

IECA transitioned our legislative efforts this year by hosting a legislative breakfast at the Capitol during the Iowa legislative session. Over the past several years, the board of directors noted that there was minimal direct impact for extension councils at past legislative events that partnered with Iowa 4-H. The IECA Finance/Policy/Legislation Committee developed a foundational event that capitalized on our 100-county campus to invite legislators to the February 15 breakfast. Extension council members across the state were asked to personally invite their legislator(s). At the breakfast, approximately 60 senators

and representatives were presented with stakeholder reports and financial data for each county in their legislative district. Of course the hot coffee and breakfast burritos were a big hit as well! The goal of this first breakfast was to make connections, familiarize attendees with Extension and Outreach, and begin to lay the groundwork to educate about how Extension and Outreach is funded. Plans are already underway for a breakfast at the Capitol in February 2024.
