

There is a limited time to complete the screening, so be sure to start today.

After creating your password, you will answer a set of screening questions and then submit your responses to County Extension & Outreach. When the final report is completed, you will get anytime access to your own background screening report.

The screening process typically takes up to 5 business days, but could take longer depending on the items selected for screening. Once submitted, you will need to follow up with County Extension & Outreach for any updates on the status of your application.
