

Endowment Rate of Return




Benefits of an Endowment






How Does the Process Work?

- County establishes endowment fund
 - Type of Fund
 - Purpose of funds
 - Committee to oversee
 - Extension Council Rep
 - 4-H Staff
- Solicit funds locally
 - Submit to Foundation using Deposit form
- Withdraw to support programs
 - Quarterly withdrawals



Donor Best Practices

- Acknowledge Contribution

 Tax receipt vs. stewardship
- Ensure donor intent is followed
- Showcase impact of giving




Food for Thought
